Jessica,

We are ready to approve the Form 28 for the above referenced Facility, but prior to that the COGCC is need of additional financial assurance. Please provide additional financial assurance as indicated in your estimate provided in the submittal. Upon receipt of the additional \$1.5 M, there will then be a condition of approval (COA)

on the Form 28 permit stating below:

A Financial Assurance of \$500,000 has been provided (Surety ID: 20140095), covering closure, remediation, and reclamation of Pit Facility ID: 439235. Black Hills has provided a financial assurance estimate of \$2M. The COGCC is having a third party review the closure of the facility and prepare an independent closure cost estimate. Based on the third party review, if there is a short fall of the \$2.0 M, the Operator shall provide additional financial assurance prior to fluids entering the two additional proposed Pit Facilities and their first use.
