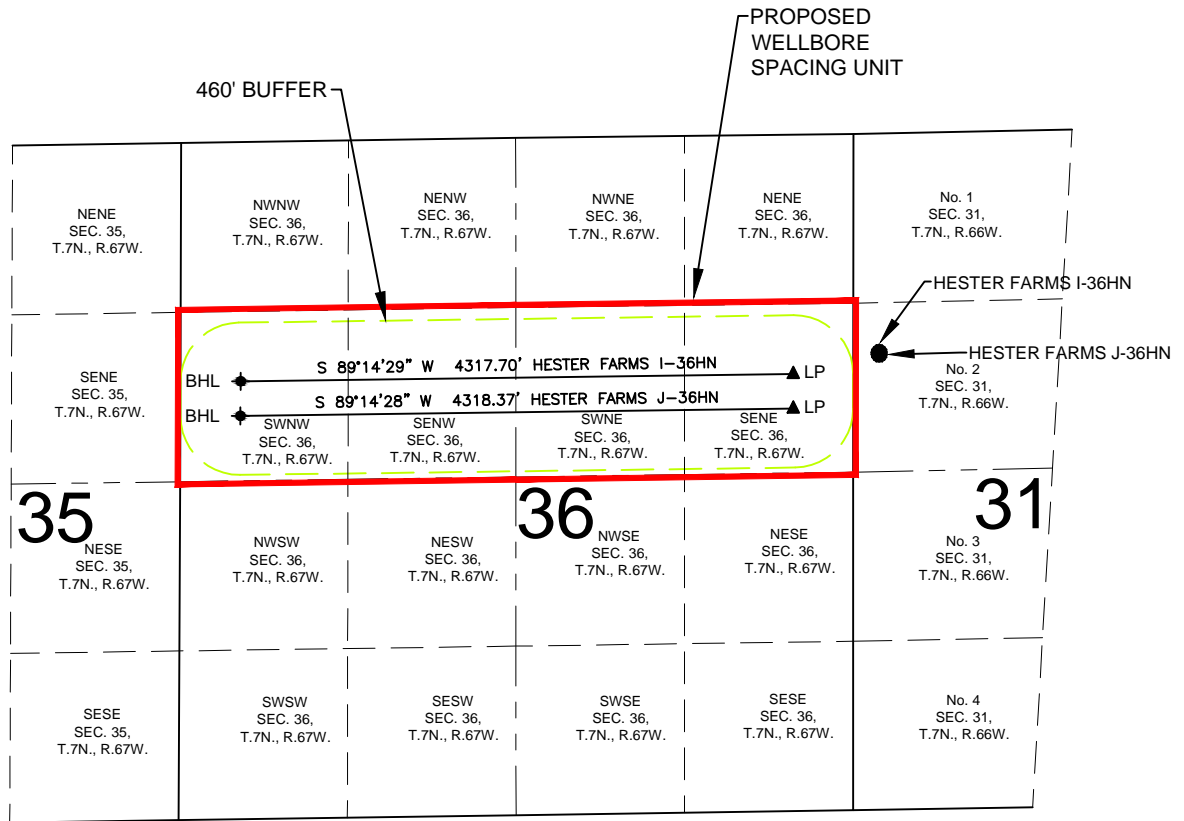

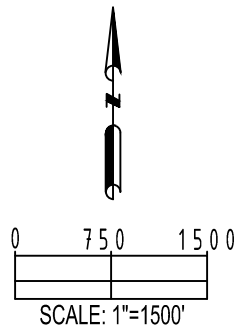
HESTER FARMS 31-H PAD **PROPOSED 318A.e. SPACING UNIT** **SEC. 36, T7N., R67W: S2N2**
