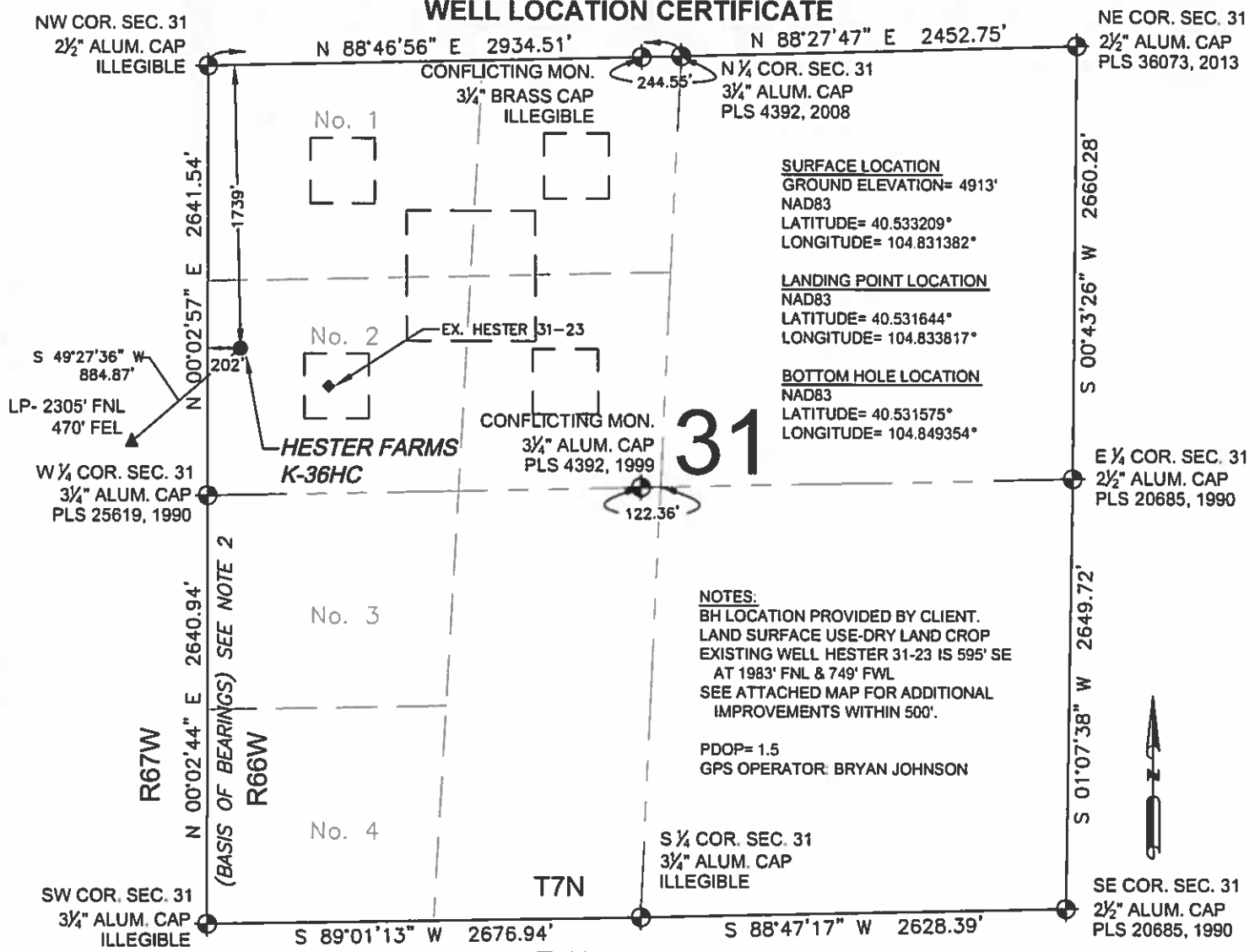


# HESTER FARMS K-36HC WELL LOCATION CERTIFICATE

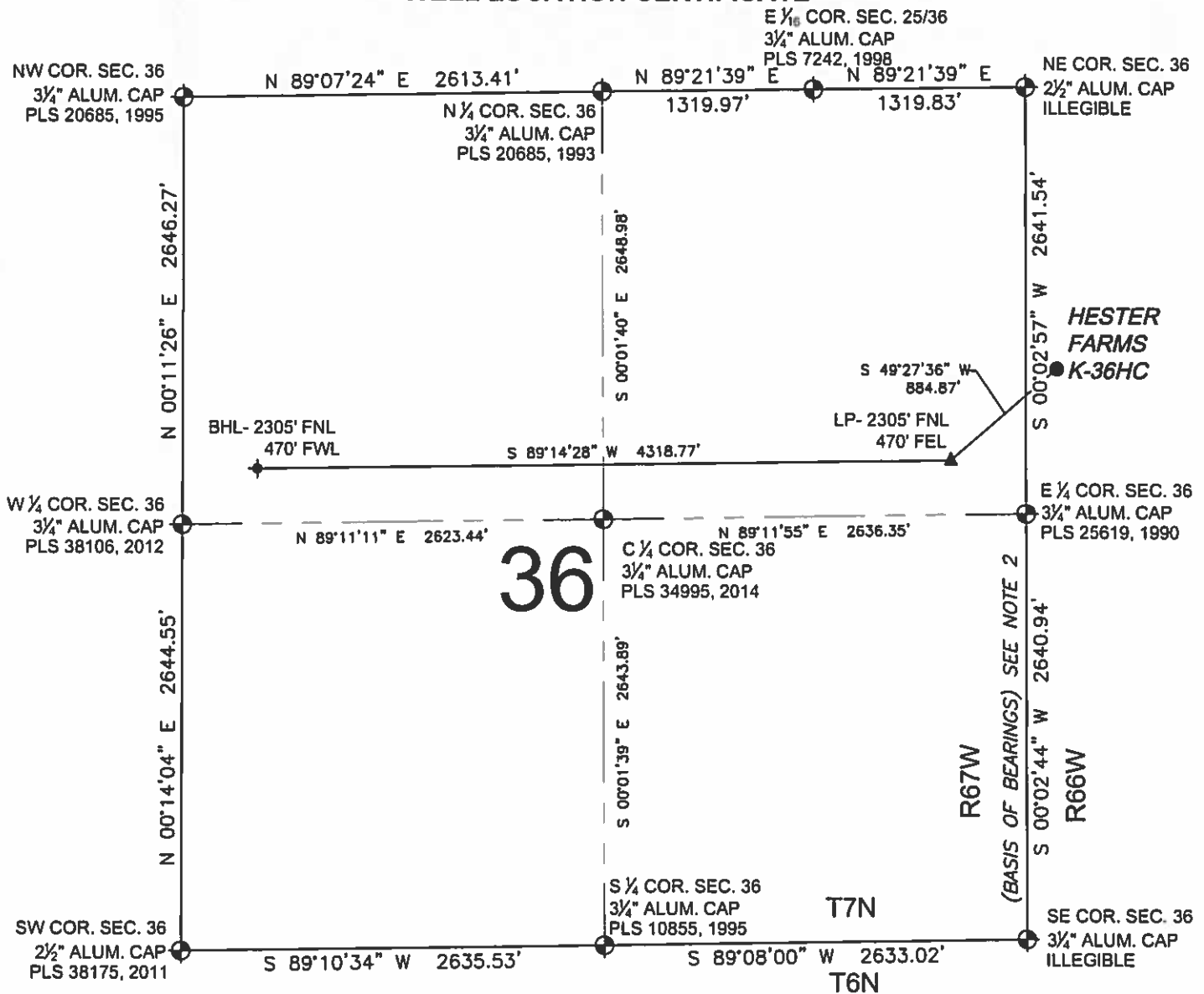

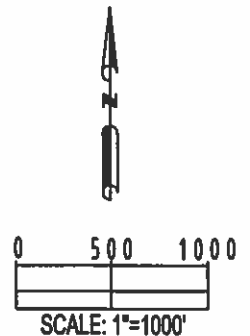

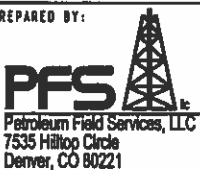
