Watson Ranch B 24AWI-17-07-95 injection wells water sampling and frac gradient calculation procedure:

- NU 5" Frac Tree with two (2) 10K frac valves. Pressure test casing and valves to 8,000 psi.
- RU wireline company w/ lubricator.
- Perforate Stage 01 and portion of Stage 02 (to sample Cozzette and Corcoran)
- RIH w/ packer and 2-3/8" tubing. Set packer at 20' above top perf of Stage 01
- RD Gauge, release pressure. Swab back tubing / exposed casing volume + 11 bbls.
- Utilize on-site test to determine TDS. Call engineer with TDS number.
- Submit sample to Multi-Chem technician on-site. Lab analysis will be submitted to COGCC.
- Perform DFIT - Install surface pressure monitoring gauge on casing. Inject 40 bbls water with rig pump.
- SD pump, monitor pressure for 12 hours. DO NOT BLEED DOWN PRESSURE on casing. Submit data to engineer for review
