Proposed Procedure:

1. MIRU. Pull production tubing.
2. TIH with casing cutter. Cut off 4 1/2" casing at 6100'. Pull 4 1/2" casing.
3. TIH with tubing to 6150'. RU cementers. Mix and pump 50 sks of 15.8#/gal CI G cement.
4. Reset tubing at 900'. RU cementers. Mix and pump 330 sks of 15.8#/gal CI G cement. Cement should circulate.
5. Cut surface casing 6' below ground level and weld on cap.
