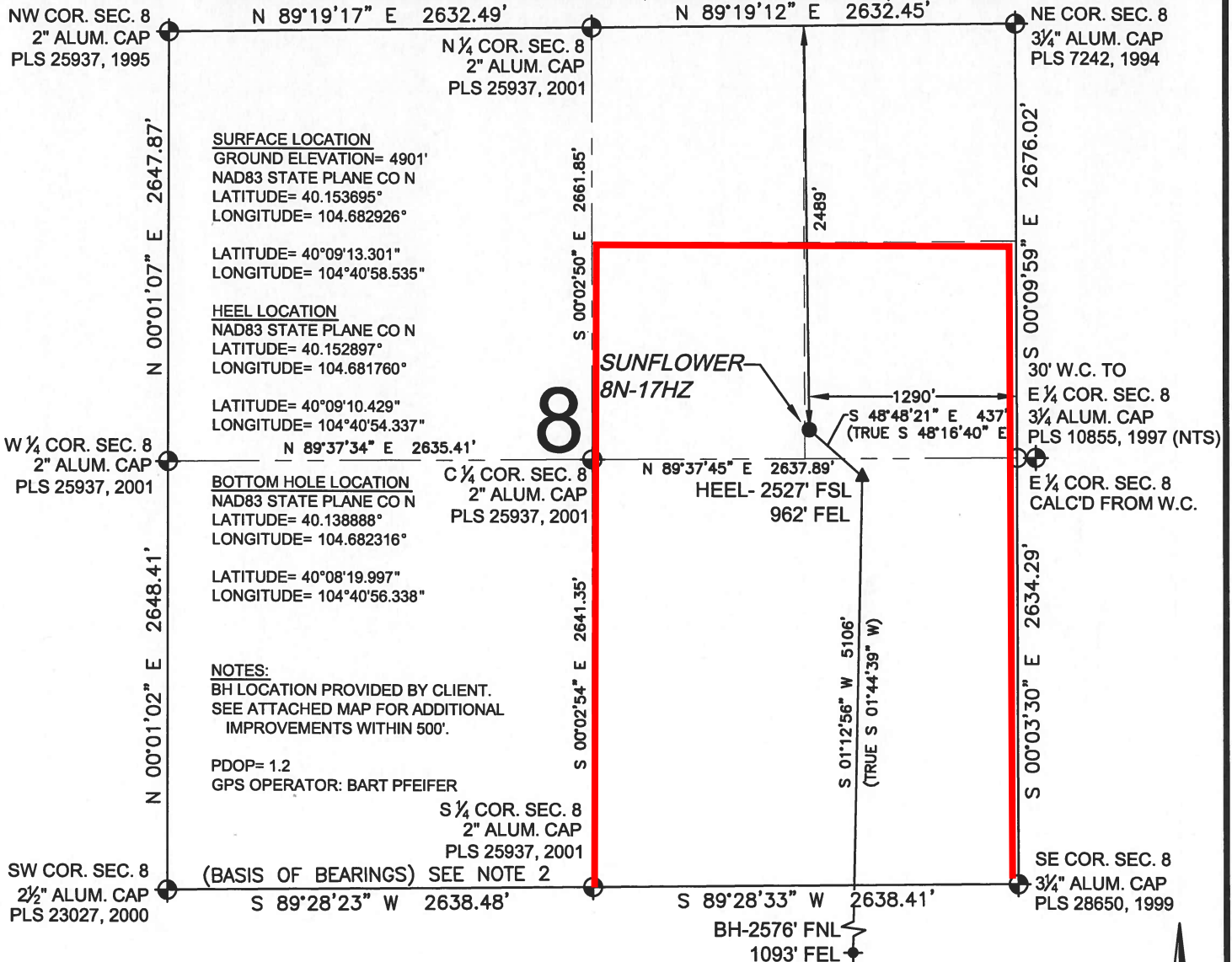

WELL LOCATION CERTIFICATE: SUNFLOWER 8N-17HZ

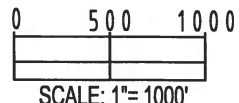
SECTION 8, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.

WELL SUNFLOWER 8N-17HZ TO BE LOCATED 2489' FNL AND 1290' FEL

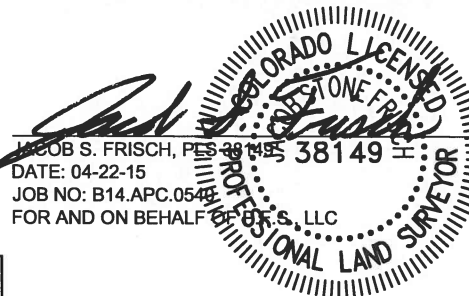
