**COMMENTS:**

Move in workover rig, kill well if necessary, release packer and pull out of hole with production tubing and packer. Run in hole with work string and scraper to begin a wellbore cleanout. Following cleanout, pull out of hole with work string. MIRU pump and tank. RIH with RBP, squeeze packer and tubing. Pressure test casing to determine wellbore integrity. If casing leak is discovered, squeeze well with 100 sacks neat cement. If squeeze holds, shut in overnight to let cement set up. Pull out of hole with packer and work string, RU pump power swivel and drillout squeeze. Pressure test squeeze. If holds, RIH and retrieve RBP. Pull out of hole with workstring and RIH with production tubing. RU tubing swab and swab back well. RDMO workover rig.
