This sundry is being submitted to change the cementing/ casing design of this well to a monobore. An oil-based mud system will additionally be used. A sundry for the Troudt location has been submitted for the Waste Management Plan to reflect this shift from a water-based mud. An offsite commercial disposal plan was already in place. Our cementing/ casing plan does provide coverage for the Upper Pierre Aquifer in this area as the long string of this well will be cased to surface and cemented up into the surface casing.
