Dear Mr. Lepore,

Pursuant to COGCC Rule 303.i.(2), the Director may issue a permit at any time in the event that an operator files a sworn statement and demonstrates therein to the Director's satisfaction that due to exigent circumstances, significant economic hardship to a drilling contractor will result or significant economic hardship to an operator in the form of drilling stand by charges will result.

Extraction Oil & Gas, LLC (Extraction), as operator of the Cox 1 Well Document 400829133, Cox 2 Well Document 400829183, Cox 3 Well Document 400829234, Cox 4 Well Document 400829266, and Cox 5 Well Document 400837750, respectfully request expedited approval of the subject Form 2 APDs, due to extenuating circumstances caused by rig stand-by charges. Extraction is planning to move onto location to begin building the access road and site location July 15, 2015. Accordingly, the current rig schedule is set to spud these wells on July 24, 2015.

Pursuant to COGCC Rule 305.d. the Director shall not approve a Form 2A, or any associated Form 2, for a proposed Well or Production Facility for twenty days from posting and shall accept and immediately post on the Commission's website any comments received from the public, the Local Government Designee, the Colorado Department of Public Health and Environment, or Colorado Parks and Wildlife regarding the proposed Oil and Gas location. Extraction respectfully requests waiver of the 20-day public comment period in order to expedite the COGCC approval of the Form 2 APDs for the Cox 1 through 5 Wells.


