- 1) MIRU rig
- 2) Pulled production tubing
- 3) MIRU wireline
- 4) TIH, set RBP @ 6708' (50' above top perf)
- 5) TIH w/ CBL; run from 4000' up; contact state for possible approval of cement top. If approved, move to step 7, otherwise see step 6.
- 6) TIH (4-1/2" x 7-7/8" annulus) with 1 1/8" work string and cement annulus from 3632' – surface
- 7) Install 5k wellhead
- 8) RDMO

\*Well files indicate casing patch in 2004 with annular fill behind pipe from 3600' with 180 sacks 1.1 yield cement and 250 sacks 3.3 yield cement, putting TOC @ surface. No CBL was run to confirm.
