#### COMMENTS:

MIRU work over rig to fix a hole in the casing. Set a bridge plug and hunted for holes with a packer. Hole found between 2950-3810. Chemical cut the casing @ 3822'. Lay down 89 jts of casing. TIH with 89 jts 4 1/2" 10.5# M-65 casing and a casing patch. Pressure tested patch to 1500 psi for 5 minutes. Run tubing down annulus to cement top (3985'). Pumped 60 sacks of Class G neat around patch and cemented to surface with Premium Lite cement. TIH with blade bit and cleaned out to CIBP. Drilled out CIBP and chased it to bottom (6775'). TIH with 2 3/8" tubing landed @ 6690'. See actual wellbore diagram and annular fill report attached.
