Any trash or pad underlayment will be hauled to a state approved disposal facility and then the pad will be reshaped and contoured as per the attached exhibit. Once the pad dirtwork is completed, the pad will be seeded with mix appropriate to the area and elevation. Stormwater BMP's will be re-installed to manage water and weeds will be treated per Piceances ongoing weed treatment and management plan.
