WPX Energy requests approval to install a temporary 2" surface steel pipeline that will supply fuel gas from the RU 23-5 pad to the rig that will be drilling on the RU 21-8 pad. The pipeline will be located on the surface in an existing pipeline ROW and along the access road to the RU 21-8 pad. The line will be placed in areas that have previously been disturbed. The line will be removed once drilling is completed which is expected to be end of May 2016.
