All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured while-drilling gamma-ray log. New spacing unit: W2SW of Section 7, W2W2 of Section 18 in 4N 64W and E2SE of Section 12, E2E2 of Section 13 in 4N 65W. 480 acres.

The Honebein 7G-323 will have a treated interval less than 150' from the treated interval of the Honebein 13-7U. All wells are owned by PDC Energy, Inc. so no stimulation setback consent is needed.
