Jennifer,

COGCC is in the process of reviewing the Johnson Trust Form 2A (doc no 400689054). In order for COGCC to complete the review of this 2A, please address the following:

1. The BMP for Green Completions does not meet COGCC requirements directing salable gas to sales line. Please update this BMP to include sales line information.

**Please update the BMP to read as follows:**

**Green Completions - Emission Control System: Test separators and associated flow lines and sand traps shall be installed on-site to accommodate green completions techniques pursuant to COGCC Rules. There are plans to tie in with Anadarko sales lines nearby.**

The Lighting BMP has the caveat "where possible." Based on the proximity of the location to housing developments, BMPs for lighting are required. Please provide an updated BMP.

2. **Please update the BMP to read as follows:**

3. **Lighting: Site lighting will be directed downward and inward and shielded to**
4. **avoid glare on public roads and Building Units within one thousand (1000) feet.**
5. **Once the drilling and completion rigs leave the site, there will be no**
6. **permanently installed lighting on site.**

3. Please provide information regarding the potential use of an electric rig for this location.

**Extraction intends on powering the drilling rig off of high line power, which would eliminate the noise caused by the generators on the rig. This noise mitigation solution requires proper infrastructure supplied by United Power, however, this is out of Extraction's hands in terms of proper power supply. If the drilling rig cannot be powered by the nearby high line power, sound blankets shall be utilized on the rig floor as an additional noise mitigation measure.**

**Additional Noise BMP:**

**Operator will be paying for, installing and maintaining landscape screening and building a three foot berm to the north side of facilities closest to building units. The proposed grading of the pad will aid in sound mitigation as the pad has been designed to be significantly lower than existing grade.**

4. Please provide information on discussions with the Town of Fredrick regarding traffic plans.

**A traffic impact study was completed and is a part of the application that is in process at the Town of Frederick.**
