I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Water Resources section you have indicated the estimated depth to groundwater is 320 feet based on water well permit #106305. A review of that water well permit indicates 320 feet is the total depth of the well and the static water level is 40 feet. Therefore, I would like to change the estimated depth to groundwater from 320 feet to 40 feet.

2) In the Water Resources section you have indicated that YES the location is in a riparian area and YES an Army Corp of Engineers (ACOE) Section 404 permit has been filed. During my review, I did not see any evidence that this proposed oil and gas location is in a riparian area and no ACOE Section 404 permit is attached to the Form 2A.
