A sundry for the Waag location (ID# 439204) has been submitted for the Waste Management Plan to reflect this shift from a water-based mud system. An offsite commercial disposal plan was already in place.

Our cementing/ casing plan does provide coverage for the Upper Pierre Aquifer as the long string of this well will be cased to surface and cemented up into the surface casing.
