Authorization: Greg Reeves Wheat Farm has authorized Grynberg Petroleum for disposal under the COGCC policy. (Exhibit B)

Description of Land Use: Dry Land Agricultural

Description of Dump Site: When entering dump site off WCR 100 all dump sites are staked and communicated by land owner. Dump site is not in a sensitive area and no wetlands or surface waters exist.

Background sampling and analysis: Please contact LT Environmental regarding sampling. Greg Reeves owner and operator of Greg Reeves Wheat Farm will be available for landsite inspection. Please call for an appointment (970) 381-7272. County planning determined the land use is Dry Land Agricultural and all activity is for agricultural use.

Description of Benefit to Native Soil: Drilling fluids and cutting will be used as a soil amendment for agricultural land. The soil amendment is beneficial for soil erosion and nutrient.

Estimated Material Volume of Material: 540 Tons

Description of Material Handling: No pretreatment of drilling fluids and/or cuttings will be applied. All well site material will be held in frac tanks with secondary containment or 3 sided storage bins. Any material that cannot be treated onsite and/or cannot be transported directly to Greg Reeves Wheat Farm will be disposed of at Waste Management's Ault facility.

Description of Material Tracking: All material handling will be documented on a field ticket (Exhibit C) and mud waiver. (Exhibit D)

Land application facility will not be mixing and will be incorporated within 10 days. All incorporation will be less than 3 inches with spreader. Any runoff and/or sediment are currently controlled by disking outer perimeter of field. Hauler will be tracking loads and bbls as indicated on field ticket by driver. Location and private road ways will be sprayed with clean freshwater, as needed. Due to immediate incorporation odor control is not an issue. We are not anticipating any frozen or muddy conditions that would prevent timely incorporation, at this time.

Confirmation Facility will receive Drill fluids for < 3 year: Confirmation has been received from Greg Reeves Wheat Farm, land application facility, confirming drill fluids will not exceed 3 years.
