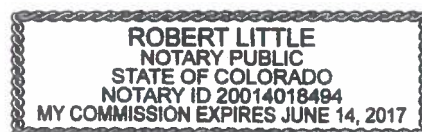

PROPOSED UNDERGROUND INJECTION CONTROL  
PERMIT**

**PURPOSE OF PUBLIC NOTICE:**

The purpose of this notice is to solicit public comment on the NGL C12 disposal well, a Class II injection permit submitted by NGL Water Solutions DJ, LLC. The NGL C12 disposal well has a planned drilling location 2,312 feet from south line and 935 feet from east line NESE Section 27, Township 5 North, Range 63 West, 6th P.M., Weld County, Colorado.

**BACKGROUND**

Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploratory and production operations. NGL Water Solutions DJ, LLC has proposed to inject these fluids into the (top down) Lyons, L. Satanka, Wolfcamp, Amazon, Council Grove, Admire, Virgil, Fountain, Missouri, Des Moines, Atoka, Morrow, and Mississippian Formations in the NGL C12 well through an open hole completion at depths of approximately 8,235-9,961 feet.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning proposed injection well permit, the Director may request that the Commission hold a hearing on the matter.

Additional information on the operation of the proposed injection well may be obtained at the Commission office.
