#### COMMENTS:

Had downhole issues on 8-25-15, dump bailer left cement at 7,353, Lower part of CBL from 7,25-15 not accurate. Ran bit to BP at 8,215, then tried to re-run CBL from 8,200'. The tool kept hanging up, did get CBL showing cement from 7,780 up to 7,556' from primary job. Called COGCC, talked to Dirk Sutphin and explained issue, he agreed the BP was set in cement and within 100' of perms. Will allow to go forward with squeeze across 3,275 - 3,210' upon review of CBL.
