In accordance with Rule 305 of the Colorado Oil and Gas Conservation Commission ("COGCC"), this letter serves as a 30-day notice by Wiepking-Fullerton Energy, L.L.C. (W-F) of its intention to drill one well from the above captioned location. W-F's operations are estimated to begin within the next thirty 30 days pending receipt of required permits, approval of title and drilling rig availability. COGCC regulations provide that the surface owner may waive the 30-day notice requirement.

In accordance with Rule 306 of the Colorado Oil and Gas Conservation Commission ("COGCC") requires written notice from the surface owner to request or waive a consultation meeting with W-F concerning the location of the above referenced well and all associated equipment.

Enclosed is a waiver and request for consultation form. Please read and fill the form out stating your decision on the thirty (30) day notice and consultation meeting as required by Rule 305 & 306 of the Colorado Oil and Gas Conservation Commission ("COGCC"). As the surface owner, it is your responsibility to notify any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations.
