COMMENTS:

07/26/15 (11:45 AM): Operator discovered gas venting in the vicinity of its Young #13 gas storage observation well.
07/26/15 (01:00 PM): One hour and 15 minutes after the leak was detected, well was opened to atmosphere to minimize gas flow into subsurface until a bridge plug could be set.
07/26/15 (08:00 PM): 8 hours and 15 minutes after leak was detected, a retrievable bridge plug was set at 5,780' GL; approximately 12' above perforations. Flow of gas into wellbore ceased.
07/27/15: Loaded casing with 120 BBLs water.
Prior to placement of the retrievable bridge plug in the well, an estimated total of 2.2 MMcf of natural gas and 10 gallons of produced water was released from the wellbore. It is estimated that 0.4 MMcf of the total 2.2 MMcf of gas escaped from the well and surfaced through a 1.5' - 2' (Maximum) diameter hole located approximately 20' north of the Young #13 well. The remaining 1.8 MMcf of gas vented to atmosphere through the wellhead valve.
08/03/15: Operator notified Dirk Sutphin (COGCC SE Region Engineer) of situation with Young #13 Well.
08/04/15: Operator provided Kym Schure (COGCC Field Inspector) with photograph of incident area. Hole has been backfilled by operator.
The estimated 10 gallons of produced water is below the threshold for reporting on COGCC Form 19.
Operator is currently formulating plans to determine actual location of casing leak.
Operator plans on plugging and abandoning Young #13 well after COGCC Form 6 (Well Abandonment) process is complete.
