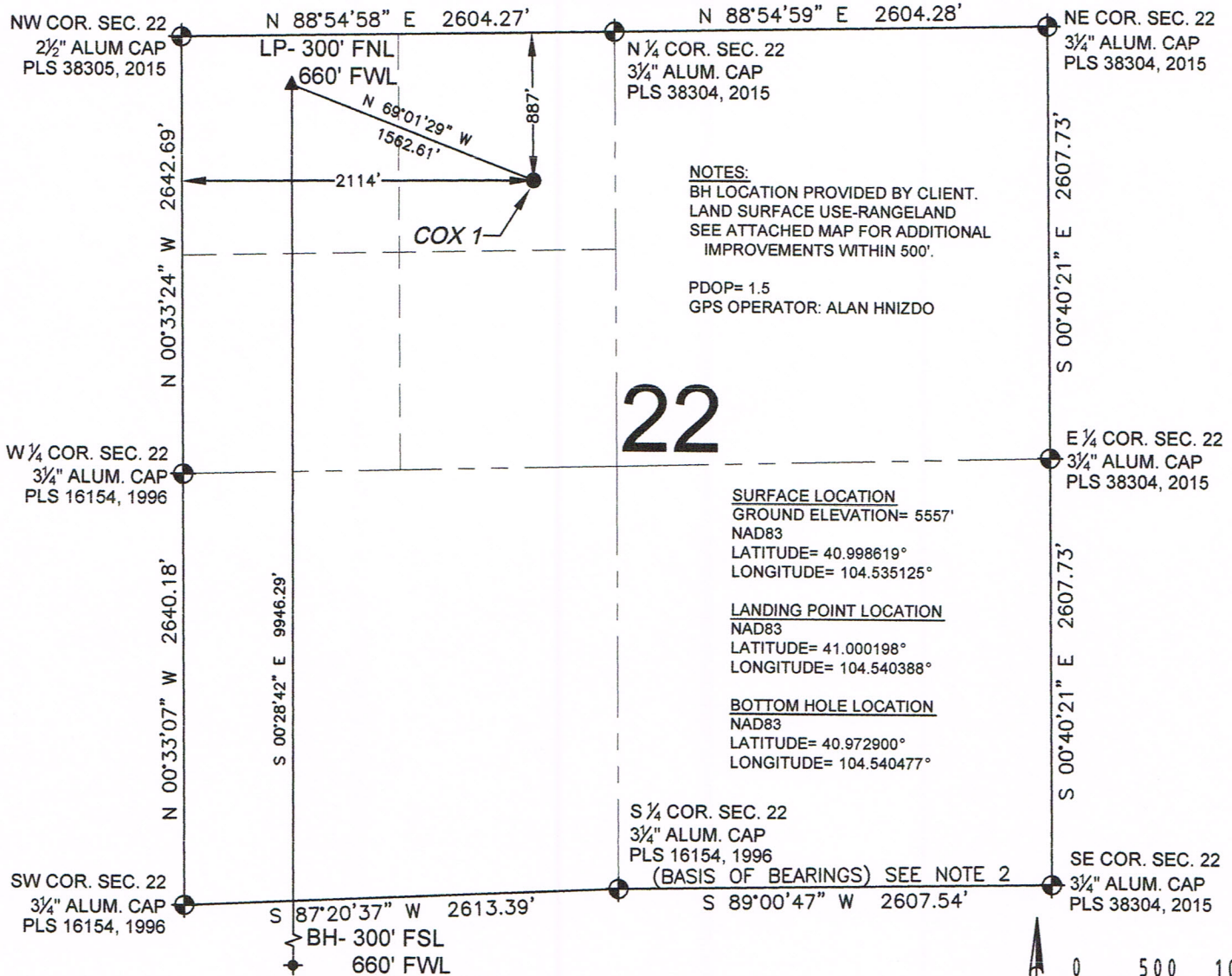


COX 1 WELL LOCATION CERTIFICATE

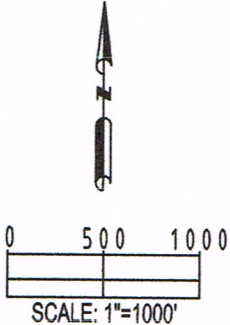
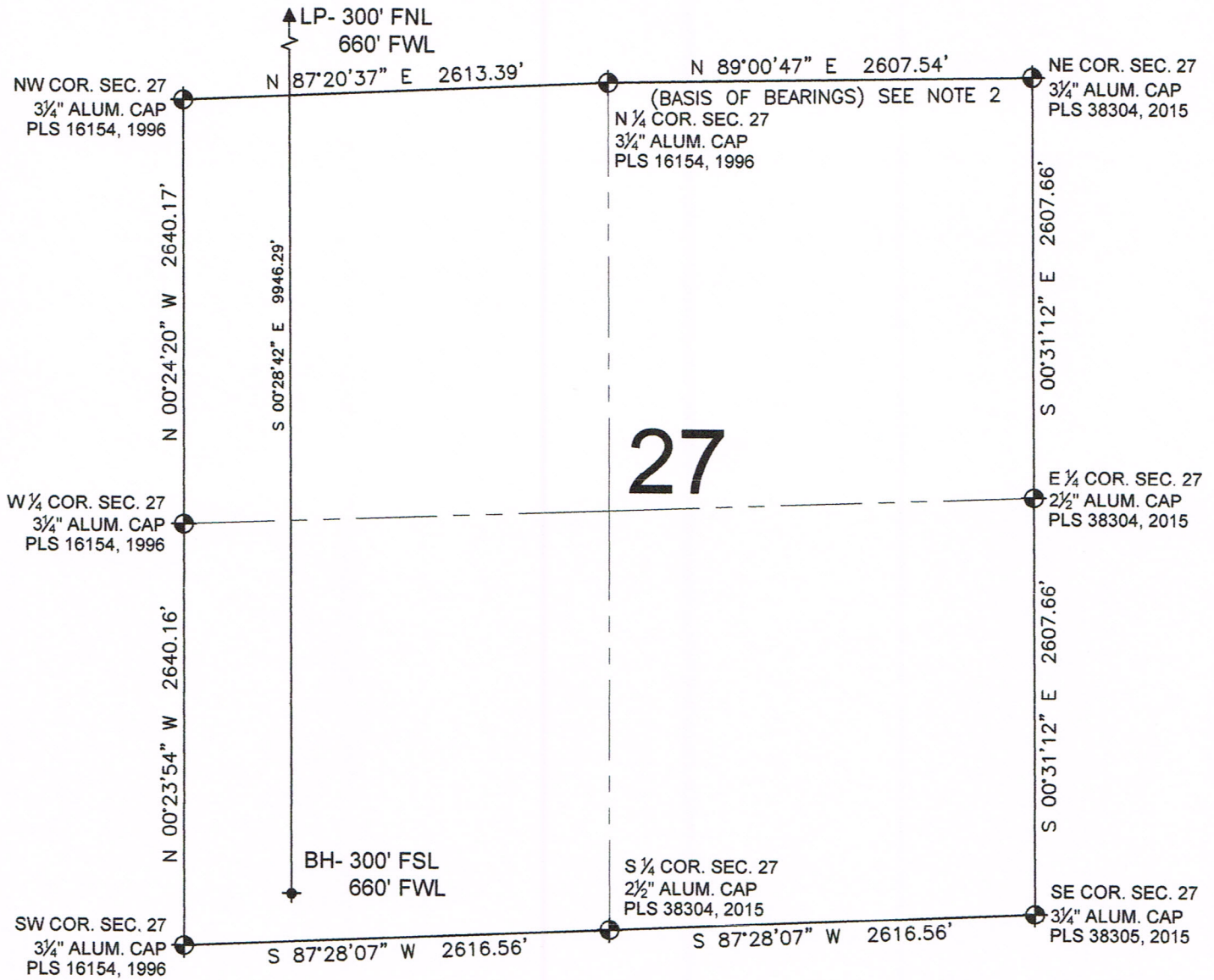

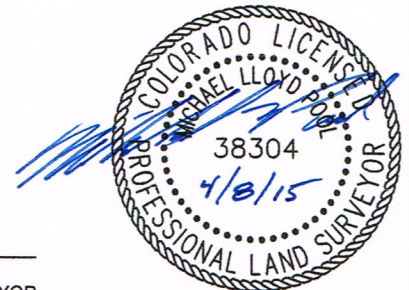
COX 1 WELL LOCATION CERTIFICATE
