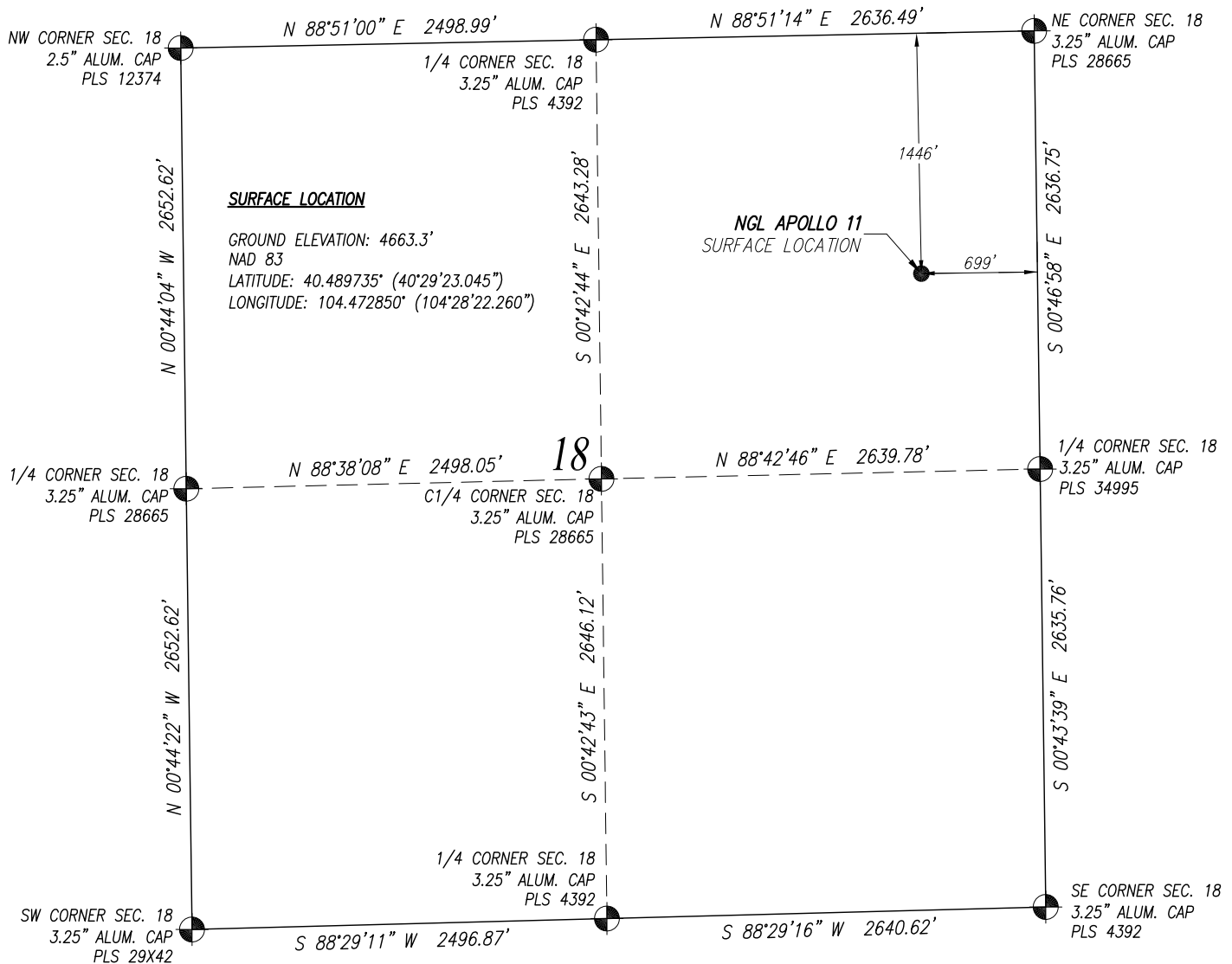


# WELL LOCATION CERTIFICATE: NGL APOLLO 11

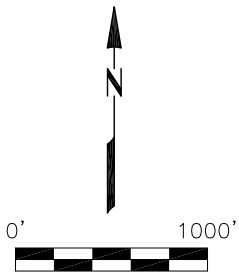
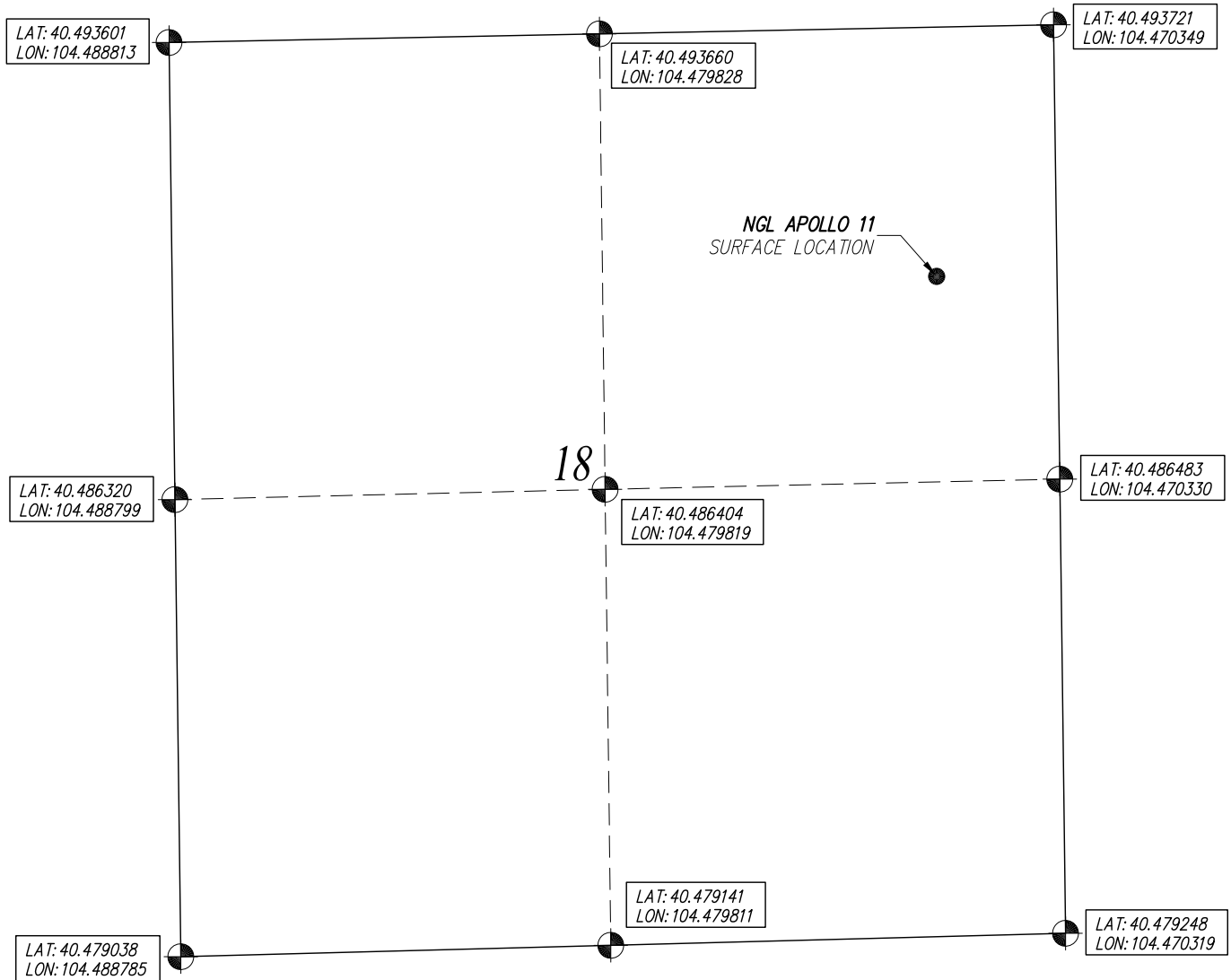
