Operator Comments:

The CIBP run on wireline for the MIT set prematurely at 5850' in a tight spot in the 11 7/8" production casing. This is 180' above the top of the producing interval. A gauge ring run prior to setting the plug indicated tight spots in the casing and the CIBP was run as deep as possible in an unsuccessful attempt to get to within 100' of the producing interval. The 11 7/8" production casing set at 6030' is cemented to surface. The 16" intermediate casing set at 5089' is also cemented to surface, as is the 20" surface casing set at 465'. Deepest ground water in the area is in alluvium at approximately 100' from surface. Prior approval for setting the CIBP greater than 100' above the producing interval was not obtained from COGCC. The well was successfully MIT'd above the CIBP at 5850'.
