There was no 404 permit submitted to the Army Corps of Engineers because it was not needed. There was a different Nationwide permit submitted which is what my comment refers to. I apologize for the confusion here. Let me know if you have any questions on this!

2. Please provide a Green Completions BMP for the salable gas time frame in regards to flowback and production.

604c.(2).C. Green Completions: Temporary above ground polyethylene water pipelines will deliver water to location operations from larger trunk lines to reduce truck traffic and minimize air pollution. Pipeline infrastructure is in place prior to completions operations to ensure saleable gas, once hydrocarbons are cut, is sent directly to sales without flaring during flowback.

Environmental Control Devices or Volatile Organic Compound (VOC) Combustors will be used to control working and breathing vapor losses for oil and water tanks.

3. At the end of the comment period, after 9 pm on 9/7/2015, please provide a 306e certification including any information regarding public comments or meeting requests.
