Extraction Oil and Gas, LLC (Extraction) is planning to drill the above referenced well in accordance with the provisions set out in Colorado Oil and Gas Conservation Commission (COGCC) Rule 318A.e. Extraction's Proposed Spacing Unit consists of:

NE¼ of Section 7, Township 6 North, Range 65 West  
NW¼ of Section 8, Township 6 North, Range 65 West  
Containing 320 acres, more or less

Extraction is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Extraction's office. The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owners within the Proposed Spacing Unit for the subject well.

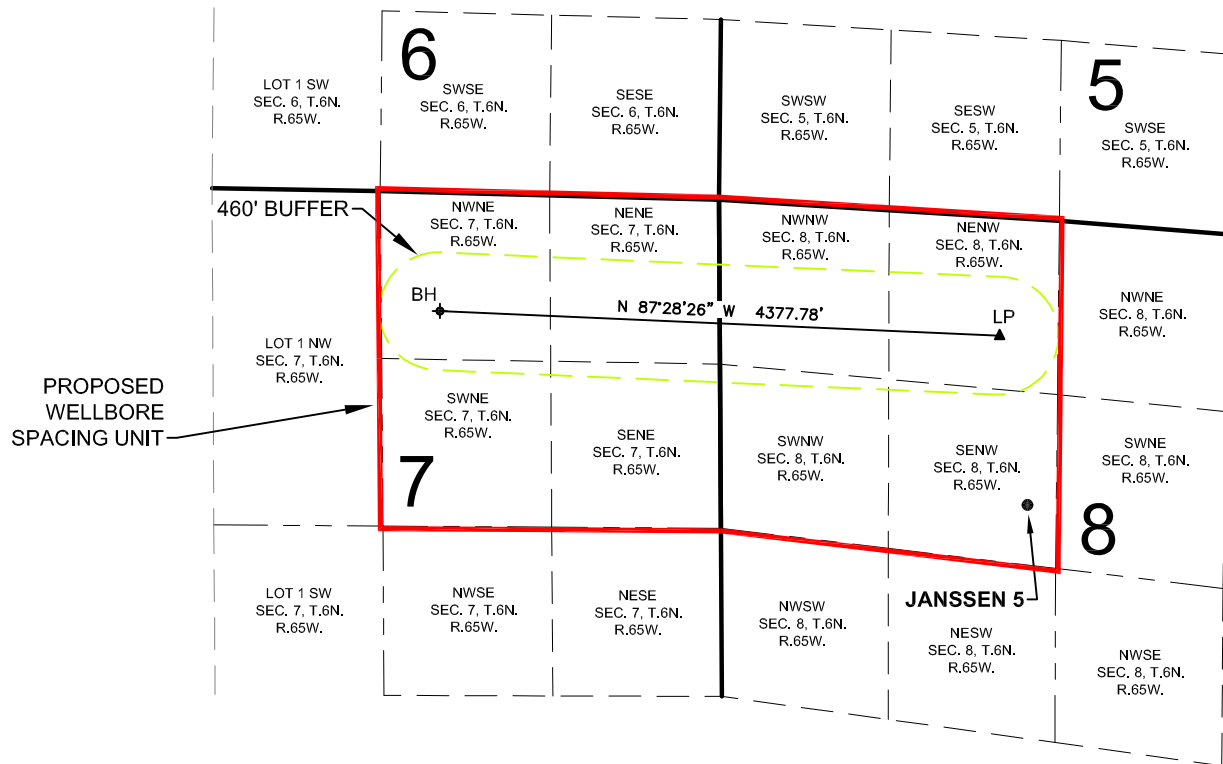

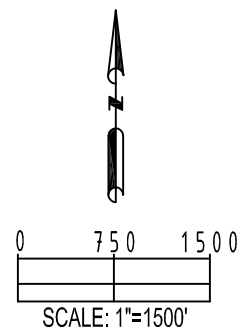
