Extraction is submitting a Form 4 Sundry based on the fact that there are no wells that we can sample both do to no permission from landowner and water well not functional.

Water Well, Permit #134176 - we sent a certified letter (5/8/2015) to landowner trying to obtain permission and tried to call (5/7/2015, 5/20/2015, & 7/10/2015) and numerous times with no return call. Landowner did not grant permission to sample well.

Water Well, Permit #78, #36153, #36152, #36151 - Sent certified letter to landowner on 7/17/2015. We spoke with Shirli on 7/21/15. She told me that her well has been dry for over 20 years. Due to well being dry and not functional, we cannot collect a baseline sample at this location.

Water Well, Permit #49094 - Sent a certified letter to landowner on 7/17/2015. Landowner did not give permission for us to collect sample at this location.

Water Well, Permit #43821 - This is a monitoring well and we do not have the ability to sample this location.

Water Well, Permit #43822 - This is a monitoring well and we do not have the ability to sample this location.

Due to all the available water well locations being unfunctional or not able to obtain permission to collect a baseline sample.
