PDC plans to drill the subject well using water based mud. However, if problems arise because of this monobore design, PDC would like to use oil based mud as a contingency plan. If the oil based mud is needed, the design will be as follows. From Surface to Surface Casing TD Spud Mud (fresh water) 8.8 ppg will be used. From Surface Casing TD to Well TD Invermul 9.6 ppg will be used. Mud and cuttings would be hauled and disposed of at a commercial facility (Waste Management). Please see the Oil Based Mud section of the Waste Management Plan attached.
