PLAN TO REENTER THE COMMUNITY 3 (FORT COLLINS FIELD - 18-8N-68W) TO RECOMPLETE IN THE DAKOTA FORMATION. WELL IS CURRENTLY A SI LYONS PRODUCER.

PLAN TO PLUG OFF THE LYONS WITH CIBP AND CEMENT. FILL HOLE WITH PRODUCED WATER AND RUN A CBL. IF CEMENT LOOKS OK. WE WILL OPEN AND TEST THE DAKOTA FORMATION.

OFFSET WELL COMMUNITY 2 (CURRENTLY A MUDDY INJECTOR) WAS A COMINGLED PRODUCER IN THE MUDDY AND DAKOTA FORMATIONS (~1978 TO 1985). WE EXPECT THAT THE DAKOTA IS CAPABLE OF PRODUCING 500-1000 BBLS OF FLUID A DAY AT A 2-5% OIL CUT (BASED ON COMMUNITY 2 HISTORIC PRODUCTION). WATER FROM THE DAKOTA IS CURRENTLY USED AS OUR "MAKE UP" WATER IN THE FORT COLLINS WATER FLOOD. PRODUCED DAKOTA WATER FROM THE COMMUNITY 3 WILL BE USED AS ADDITIONAL "MAKE UP" WATER IN OUR WATER FLOOD.
