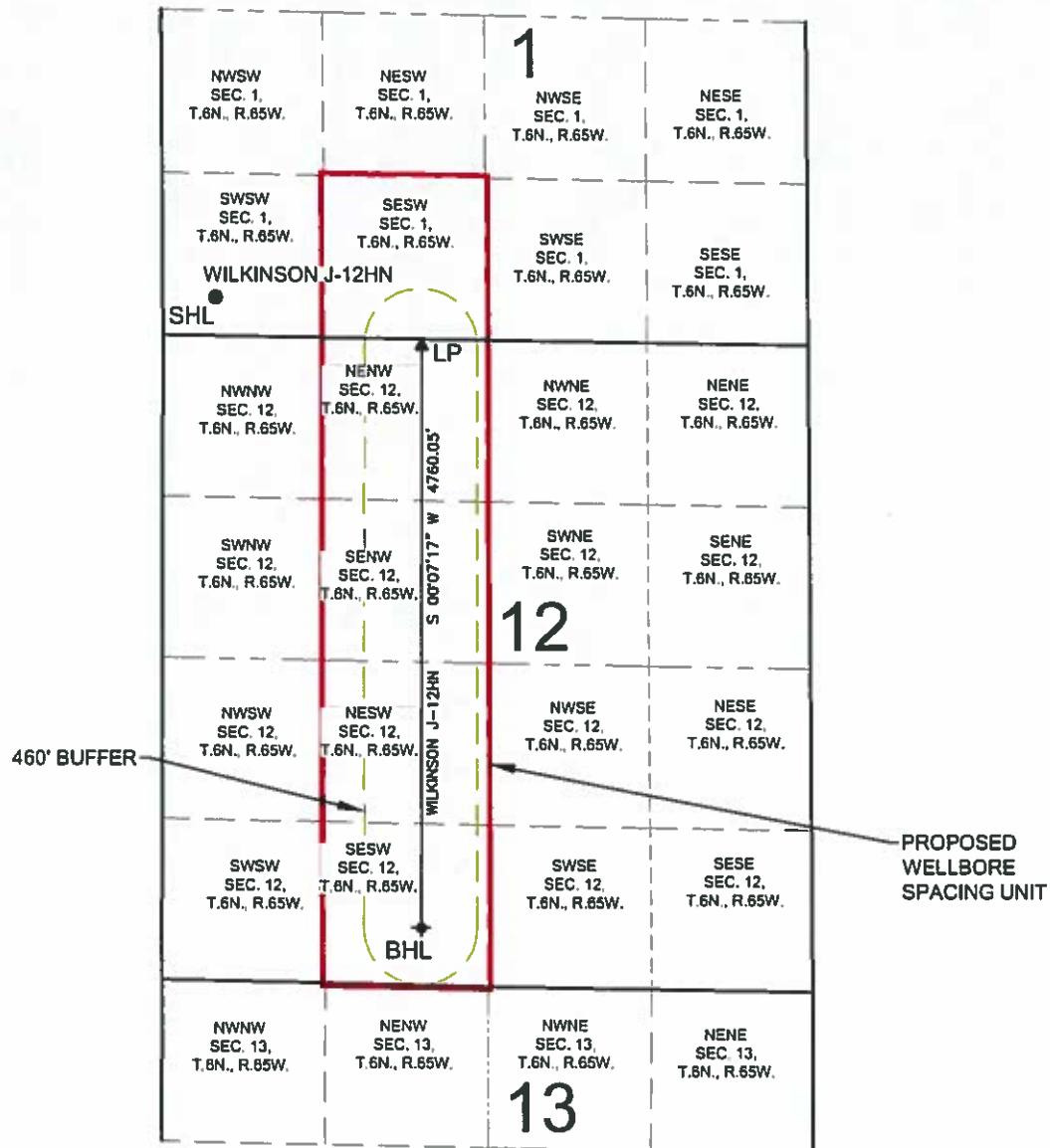

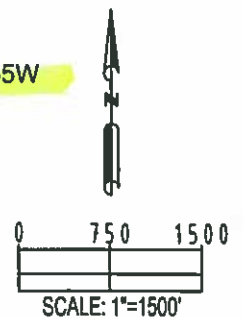
**WILKINSON 1-P PAD
