Comments:

The above location was partially constructed and is to be reclaimed at this time. Reclamation will take place as follows: The location will be re-contoured as shown on the attached Figure #1. The existing spoil pile will be used to replicate and blend with the existing terrain. All disturbed areas will be ripped to 18" centers and certified weed free straw will be placed on the area prior to the topsoil being spread. After the topsoil has been evenly spread, the disturbance will be cross ripped 6" or the depth of the topsoil layer in preparation for fall seeding. The existing access road will be ripped to the intersection of the existing road and topsoil brought from the borrow area and spread on the road. All areas of disturbance will be seeded with the following seed mix (all amounts are lbs PLS/acre): Shadscale saltbush - 2.5, Gardner's saltbush - 2, Fourwing saltbush - 2, Indian ricegrass - 1.5, Thickspike wheatgrass - 1.5, Western wheatgrass - 1.5, Bottlebrush squirreltail - .5, Great Basin wildrye - 1.5, Slender wheatgrass - 1.5, Lewis Blue flax - .5, Rocky Mtn Beeplant - .5. The area of disturbance will be fenced to prevent stock and wildlife from entering the reclaimed area. Copies of the seed tag will be submitted upon receipt from the contractor.
