Encana respectfully requests permission to extend the time to conduct interim reclamation at this location for 1 year. The surface landowner has agreed to allow Encana permission to leave the location as is at this time. Due to current budget outlooks, Encana is actively evaluating existing locations for future drilling potential. Encana plans to monitor & evaluate the location condition using the BMPs agreed upon per the Surface Use Agreement, as well as BMPs & COAs established in the approved Location Assessment & Application to Drill.
