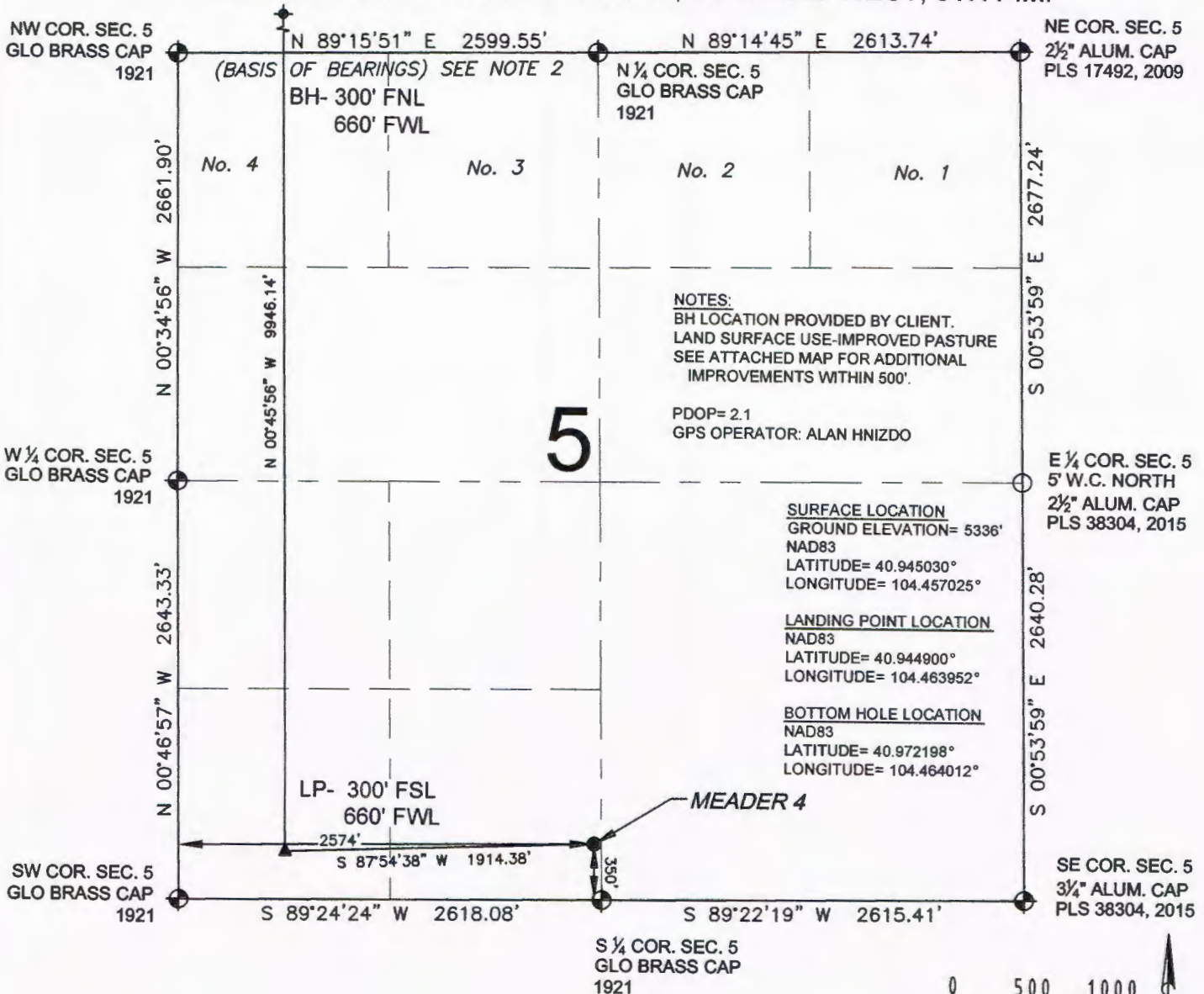


WELL LOCATION CERTIFICATE: MEADER 4

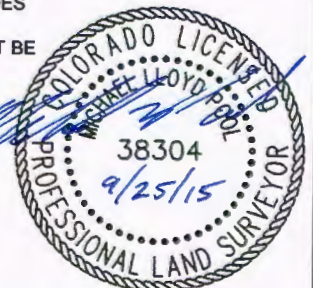

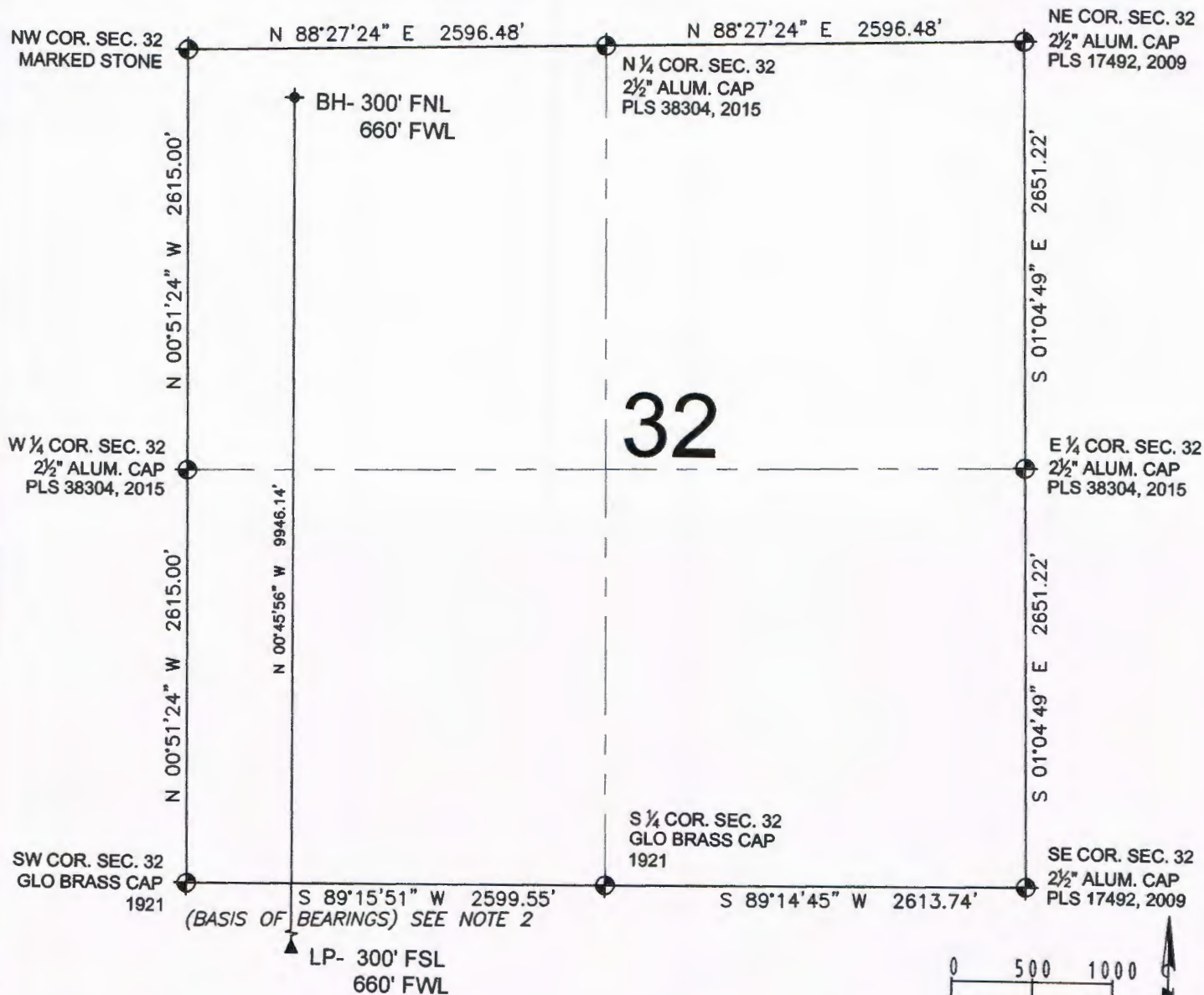
