#### COMMENTS:

Move in workover rig, kill well in necessary. Release packer and pull out of hole with production tubing and packer. Run in hole with work string and scraper to begin wellbore cleanout. Following cleanout, pull out of hole with work string. MIRU pump and tank. RIH with RBP, squeeze packer and tubing. Pressure test casing to determine wellbore integrity. If leak is discovered, squeeze well w/ 100 sx neat cement. If squeeze holds, shut in overnight to let cement set up. Pull out of hole w/ packer and workstring. MIRU wireline, perforate @ ~700' KB, 4 spf with csg gun. Provide remdial cement job from 700' to 50' above casing shoe. Let cement set up overnight. run bong log next day. RU pump and power swievel and drillout squeezes. Pressure test wellbore, if holds, RIH and retrieve RBP. Pull out of hole with workstring and RIH with production string. RU tbq swab and swab well down. RDMO workover rig.
