




# WELL LOCATION CERTIFICATE

In accordance with a request from Barney Hammond of PDC Energy, Inc., Washburn Land Surveying, LLC has determined the location of the **BROWN 23X-241** well site to be SHL: 1082' FSL and 1329' FEL, (BHL: 0' FNL and 242' FEL), as measured at ninety (90) degrees from the section lines of Sections 14 and 23, Township 5 North, Range 65 West of the 6th Principal Meridian, Weld County Colorado.


