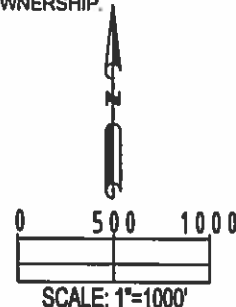

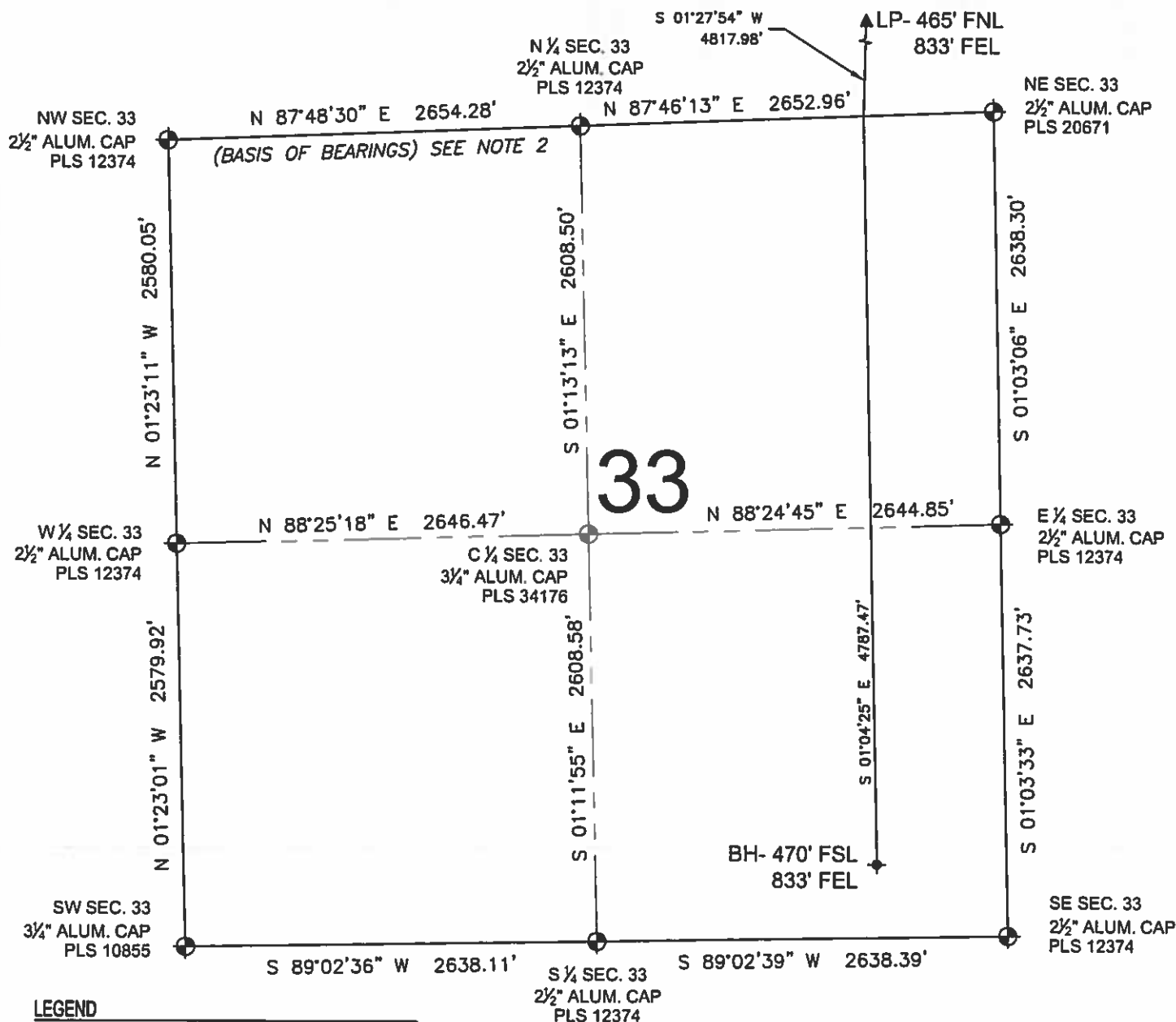

# WELL LOCATION CERTIFICATE: MOJACK N-28HN

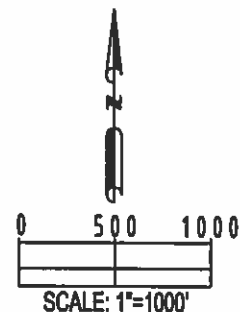
