Spud date for API 043-06196 was August 9, 2012, but to date no Form 5 Drilling Completion Report has been submitted to COGCC, violating Rule 308A. If any intervals were completed, tested, or penetrated in an open-hole completion, Javernick was required to submit a Form 5A Completed Interval Report Form 5A for API 043-06196 within 30 days of achieving total depth, unless the interval was stimulated or treated and then the Form 5A was due within 30 days of that activity, but to date no Form 5A has been received, violating Rule 308.B. Based on the August 9, 2012 spud date for API 043-06196, the first Form 7 Monthly Operations Report should have been submitted by October 15, 2012, but no Form 7 Monthly Operations Reports have been submitted to date, violating Rule 309. These violations are ongoing and the duration of non-compliance continues until the required forms are submitted.
