**EXPLANATION OF CIRCUMSTANCES:**

Per the Permit to Drill, one of the first wells drilled on the Sarchet 1-20HZ pad must have been logged with Open Hole Resistivity and Gamma Ray. The Drilling group acknowledged the logging requirement in a pre-pad meeting with Geology; however, did not plan the logging run due to a misinterpretation of Rule 317.p Guidance. The mistake stemmed from the notion that the earlier logged Sarchet 37N-20HZ, located on the Sarchet 2-20HZ pad, covered Anadarko's logging obligation for both Sarchet pads. The mistake was ultimately identified by a query generated by Anadarko's Regulatory team, but not before the rig had completed drilling operations on the pad. The COGCC was immediately notified of the matter.

**PROCESS CHANGE TO PREVENT IN THE FUTURE:**

Internal distribution of APDs will have a cover sheet, highlighting logging requirements.

A report is run and communication to Drilling and Completions teams includes logging requirements.

Logging requirements will be discussed at pad meetings prior to drilling. Attendees have been briefed on the requirements of Rule 317.p.

Please note: An Open Hole Log was run on one of the five wells on the adjacent SARCHET 15N-20HZ location, however, that well is too far away to meet the requirements of a 317.p exception on this pad.
