Jason,

Attached is the signed copy of your work plan. Please consider the following Conditions of Approval in planning your work.

- The vertical and horizontal extent of the pit should be determined through the soil investigation.
- Samples should be analyzed for table 910-1.
- Reported 56.6ft²x1in/ft=8150 in³=35gal=0.84 bbl
- Area identified as "Area c" should extend to end of berm to included full pooled part of spill.
- Any area that indicated impact (through; field screening, visual staining or odor) should be removed
- Operator should provide notice to Environmental staff Kris Neidel (kris.neidel@state.co.us) or 970-871-1963 72hrs prior to mobilization at begin of work.
- Guidance for sample locations should be taken from rule 910.b(3)B
- Final Reclamation should comply with 1004 rules.
- haul tickets for soil disposal should be included in final report.

Please submit a subsequent spill report, requesting closure, use the remediation number 9332 in the request. Also please use this remediation number on all future communication.
