Revised directional drilling plan to target new bottomhole location (1045' FNL, 1108'FEL) based off recent analysis of newly acquired 3D seismic data. An additional 281' will be drilled to reach the new depth of 4277'(TMD). The casing program has also been revised to run 9-5/8" surface casing to 1000'; 8-5/8" intermediate casing to 3200'; and lengthen the 4-1/2" production casing by 281'; all in addition to the previously proposed 13-3/8" conductor that will be set at 160' (see casing program).

An additional 281' will be directionally drilled to reach the new depth of 4277'(TMD). The casing design was also revised to include a different surface casing string and an intermediate casing string (first string) and the production casing (second string) was lengthened 281' to reach the new TMD.
