This Sundry is being submitted in response to Field Inspection Report #673402535 & #66930086.

As requested in Field Inspection Report #673402535, please find attached the flowline test results from the Surprise Unit #02-08H well in Jackson County, Colorado as well as photographs showing that the items noted on the inspection report have been taken care of.

Also, you requested sampling data from the two surface streams close to the location. The two streams are both intermittent, seasonal streams and as such EE3 LLC has not yet had the opportunity to take samples. Both streams typically flow during April and May during good snow years. EE3 LLC drilled the Surprise Unit #02-08H well in November 2014 and then shut the well in until July 2015 when it was completed and turned to sales. As such we had no operations on site during April and May when the streams were possibly flowing. It is our intent to take surface water samples in the spring of 2016.

A Form 42 Notice of Inspection will also be submitted to confirm that the site is ready for a follow up inspection.
