

## MEMORANDUM OF SURFACE USE AND DAMAGE AGREEMENT

For adequate consideration, Surface Owner and Lessee have entered into a Surface Use and Damage Agreement ("SUA") covering the following described lands (the "Property"), for the purpose of facilitating the coordinated development of the surface and mineral estates in the Property:

### **Township 15 South, Range 55 West, 6th P.M.**

#### **Section 2: All**

Among other provisions, the SUA grants Lessee certain rights, and Surface Owner hereby grants to Lessee certain rights (subject to all terms and conditions of the SUA), in the Property to drill, complete, produce, deepen, rework, frac, refrac and recomplete wells from surface locations on the Property.

The SUA also provides that Surface Owner has waived all COGCC requirements that it be given advance notice by Lessee of the operations or activities associated with operations, including but not limited to any notice required by COGCC Rule 305, consultation requirements of COGCC Rule 306, and the statutory notice required by Section 34-60-106(14), C.R.S.

Surface Owner and Lessee have agreed to record this Memorandum of Agreement in the real property records of Lincoln County, Colorado, to provide notice of the SUA.

This Memorandum is signed by Lessor and Lessee on the date of acknowledgment of their signatures, but is effective as of October 23, 2015.


