Attached with this COGCC Form 4 is the sampling summary for the groundwater samples collected in the fourth quarter of 2015. The COGCC remediation number for this project is 5258. The 2015 second quarter sampling event was completed on June 1, 2015. The results are summarized in the attached Table 1 and Table 2. Benzene concentrations in MW 2, MW3, and MW8 are exceeding the COGCC cleanup concentrations for benzene. WPX will continue the semi-annual groundwater sampling.
