THERE ARE 3-300 BARREL TANKS, WATER KNOCK OUT, TREATER, PUMPHOUSE, POWERPOLES, AND THERE IS A BURIED CONCRETE TANK BY THE TREATER. THERE IS ALSO A WATER WELL ON SITE THAT NEEDS TO BE PLUGGED OUT. WARNING

Each violation must be abated within the prescribed time upon receipt of this Notice, reported to the Colorado Oil and Gas Conservation Commission at the address shown above, and postmarked no later than the next business day after the prescribed time for abatement.

PENALTY PROPOSED BY THE DIRECTOR PER RULE 523

The Director may propose a penalty as listed in the table below, not to exceed a maximum of \$1000.00 per day per violation. Such proposed penalty amount will be limited to \$10,000 per violation if the violation does not result in significant waste of oil and gas resources, damage to correlative rights, or a significant adverse impact on public health, safety, or welfare.
