- Proposed Procedure:
1. MIRU pulling unit.
  2. Rig up wireline company. Run gyro survey from 7000 to surface.
  3. TOOH with 2?" 4.7#/ft tubing.
  4. TIH with CIBP. Set CIBP at 6600'. TIH with dump bailer. Spot 25 sxs of 15.8#/gal CI G cement on top of CIBP.
  5. TIH with casing cutter. Cut off 4 1/2" casing at 3250'. Pull 4 1/2" casing.
  6. TIH with tubing to 3300'. RU cementers. Mix and pump 50 sxs of 15.8#/gal CI G cement.
  7. Reset tubing at 610'. Mix and pump 225 sxs of 15.8#/gal CI G cement. Cement should circulate to surface.
  8. Cut surface casing 6' below ground level and weld on cap.
