Edge Energy LLC, respectfully requests "Confidential Status" for the Flaherty 18-13-12NBH API: 05-123-42434-01 well that will be spud this week. Edge plans to drill the well as a monobore with a water based mud system. Edge Energy expects the monobore drilling program to produce a unique production profile. The closest known well drilled to the same bench with a similar drilling program is a PDC well over 8 miles away. This well is located outside of the core of Wattenberg and Edge Energy plans to do extensive testing and data collection on the well.
