Dear Mr. McKinney:

Enclosed please find a Notice and Application for Hearing and Notice of Alleged Violation ("NOAV") No. 400950525 issued to Northstar Gas Company, Inc. ("Northstar Gas"). This NOAV was issued for violations of the Rules of the Colorado Oil and Gas Conservation Commission ("COGCC" or "Commission").

On April 15, 2015, an NOAV was issued to Northstar Resources, Inc. That NOAV was noticed for hearing on September 11, 2015, and has been continued to the January 26-27, 2015 Commission meeting. COGCC Staff intends to consolidate NOAV No. 400950525 with the prior NOAV so that both NOAVs may be resolved in the same proceeding.

This matter is set for an Order Finding Violation ("OFV") hearing before the Commission at its January 26-27, 2016 meeting. An OFV hearing is a full evidentiary hearing pursuant to Rule 528, where COGCC Staff and the operator present testimony through witnesses, and documents, and make arguments to the Commission. At the conclusion of an OFV hearing, the Commission determines liability for alleged violations, specifies necessary corrective actions, and assesses a penalty amount. An OFV hearing is open to the public.

Alternatively, Northstar Gas and COGCC Staff may settle the matter by agreement on liability for the violation, penalty amount, corrective actions, and other terms. This settlement agreement is called an Administrative Order on Consent ("AOC"). AOCs are subject to Commission approval, but do not involve contested hearings. A proposed AOC is attached for your consideration.


Please contact me within 10 days of the date of this letter to discuss this enforcement action. If you do not contact me within 10 days, I will begin the OFV hearing process by scheduling a prehearing conference with a hearing officer. The hearing officer will then impose filing and objection deadlines.
