Surface Casing: 8 5/8" 24# @ 327' w/ 320 sks cmt.  
Production Casing: 4 1/2" 11.6# @ 7383' w/ 275 sks cmt (TOC at 6,332').  
Proposed Procedure:  
1. MIRU pulling unit.  
2. Confirm well is dead.  
3. Rig up wireline. RIH with perforating guns and shoot 4 holes for cement squeeze at 500'.  
4. RU cementers. Mix and bullhead 165 sks of 15.8#/gal CL G cement down production casing and back up annular to provide 500 ft plug. Cement should circulate to surface on backside of production casing.  
5. Cut surface casing 6' below ground level and weld on cap.
