Kyle,

COGCC is reviewing the Subsurface Site Assessment Report prepared by Talon/LPE and submitted by Whiting Oil and Gas Corporation as an attachment to Form 19 Supplemental Spill Report #400954368 in support of a closure request for the historical contamination release at the Nelson A6,A7 Tank Battery. COGCC needs the following points clarified before the review of this closure report can be complete and the spill can be closed.

1. Clarify the sample collection locations illustrated on Figure 5 of the Subsurface Site Assessment Report. There are two sets of samples named SW-3 and SW-4 each collected on different dates with different analytical results. However, the SW-3 sample with a TPH concentration of 3,100 is shown to have been collected near the CS-7, CS-9/CS-10 soil sample locations. Is this correct?
2. It does not appear that any assessment of the northwest sidewall of the most recent excavation around CS-11/CS-12 and SW-2 was conducted. Nor has data been provided that shows that impacts documented at SB-1 (5') were removed during any excavation. Please provide data that shows that impacts to the northwest of CS-11/CS-12 and in the vicinity of SB-1 (5') were successfully removed.
3. Previous inspections conducted by me (Inspection #667400605 and #679700039) on March 24, 2015 and August 26, 2015 document that hydrovac spoils remained on location. The most recent inspection required removal of those spoils before the spill can be closed. Submit waste disposal documentation and photographic documentation that the hydrovac spoils have been removed.
